Furthermore, the WhatsApp number +91 7276987082 has been found using the unauthorised photograph of Mr. Nirmay Choksi as its profile picture. Additionally, the logo of the NJ Group is being misused in the same unauthorized WhatsApp group.

For the avoidance of doubt we would like to inform the public in general that, Mr. Nirmay Choksi - Director and Head of Investment of NJ Asset Management Private Limited, NJ Mutual Fund, NJ Trustee Private Limited, are in no way associated with these fake social media accounts / posts / Whatsapp group / Whatsapp numbers and shall not be responsible for, and expressly disclaims all liabilities for, damages of any kind arising out of the use of, reference to, or reliance on any information contained on the such social media platform, Whatsapp groups, and or any other channel / platform we are not aware of by impostors.

We advise investors/distributors not to fall prey to these fake groups / phishing websites and stay vigilant of such scams. The general public should take note as anyone who engages with the said fake groups / phishing websites, or any other platform and material promoted by the impostors does so at their own risk.
